Report on the audit of the Financial Results

Opinion

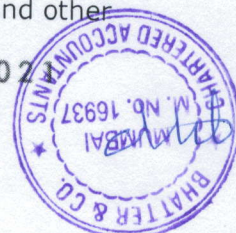
Management's and Board of Directors' Responsibilities for the Financial Results

comprehensive loss and other financial information in accordance with the recognition and measurement principles laid down in Indian Accounting Standards prescribed under Section 133 of the Act, read with relevant rules issued thereunder and other accounting principles generally accepted in India and in compliance with Regulation 33 of the Listing Regulations. - iv. 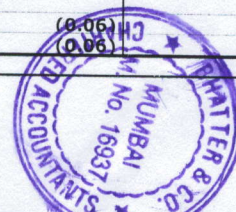

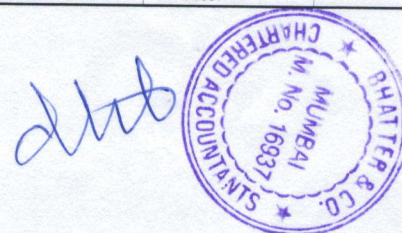
